One post of Senior Deputy Traffic Manager in the Scale of Pay of Rs.32900 – 58000 in Traffic Department, Chennai Port Trust is to be filled up by absorption through composite method from Officers of Major Port Trusts. A copy of the Recruitment Rules is at Annexure – A.

Applications are invited from eligible and willing Officers from all Major Port Trusts possessing the prescribed qualification, experience and other conditions as mentioned in the aforesaid Recruitment Rules.

The selection is 'by merit' for which, the benchmark in overall grading in the ACRs/APARs will not below 'Very Good' as per the Recruitment Rules.

The application may be submitted through online applications portal (OAP) of the Ministry of Shipping. The printout of the online filled up application should be sent through proper channel in an envelope superscribing "Application for the post of Senior Deputy Traffic Manager in Chennai Port Trust" addressed to "The Traffic Manager, Chennai Port Trust, No.1, Rajaji Salai, Chennai – 600 001" and should reach this office on or before 04/01/2020, which shall be the crucial date for determining the qualification, experience and age. 5.

The following documents are to be enclosed along with the application by the Department.

(a) Photocopy of the ACRs of the applicant for the last 5 years (upto March 2019) duly attested.

(b) Statement showing the ACR grading of the above ACRs.

(c) No Objection Certificate from the Head of Department of the respective

(d) Undertaking of the applicant not to withdraw if selected.

(e) Attested copies of all certificates, as proof of educational qualification, qualifying service / experience in the respective feeder post & pay scale

(f) Vigilance clearance of the candidate in the proforma prescribed by the Ministry (copy enclosed).

(g) The details of the applicant may clearly be mentioned along with length of service in the feeder grade posts and details of pay scales.

(h) It may clearly be mentioned whether the candidate has experience in the feeder grade posts on regular or adhoc or deputation basis.

(i) The applications of non-eligible candidates (i.e. who are not in the feeder

grade posts) may not be sent.

(j) The veracity of the University Certificates and the recognition of the Degree obtained by the applicant may be ensured and certified.

(k) Three copies of the recent passport size colour photograph. Circular along with annexures is also available in our website www.chennaiport.gov.in.

How to Apply

(a) Eligible officers are to apply in the 'Online Application Portal' of the Ministry of Shipping (http://onlinevacancy.shipmin.nic.in). The applicant has to register in the Online Application Portal.

through proper channel before due date of receipt of application.
