

# MARINE DEPARTMENT PORT RECEPTION FACILITIES AS PER MARPOL

The Master of the Vessels calling at the Chennai Port shall utilize the services of any of the empanelled service providers for disposal of wastes from the ships as and when required. The list of service providers along with the charges are given below and the Masters shall engage the Service providers at their choice and shall make payment as per the tariff given below directly or through the Vessel's Agent to the Service Provider. The requirement of the Reception Facility with the details of the waste and quantity or any feed back on the reception facility may also be sent through e-mail to <u>dc@chennaiport.gov.in</u>. In case of any difficulties, the Nodal Officer may be contacted.

#### PROCEDURE FOR EMPANELMENT OF WASTE OIL RECYCLERS IN CHENNAI PORT TRUST FOR COLLECTION OF OILY WASTES FROM THE SHIPS

- 1. The Chennai Port is permitting the Recyclers authorized by the TNPCB for collection of oily wastes from the ships as and when required by the ships as a measure of providing Reception Facility to the ships as per the MARPOL Regulations.
- 2. The waste oil recyclers having authorization from Tamil Nadu Pollution Control Board are eligible for empanelment for collection of waste oil from the ships calling at Chennai Port.
- 3. The recyclers having valid authorization from the TNPCB shall submit a request to the marine department enclosing copies of the consent / authorization issued by the pollution Control Board.
- 4. After scrutiny, if everything is in order, the Marine Department will send information to the Recycler to produce the original consent / authorization / pass Book for verification.
- 5. After verification of the originals if the authorization is valid and confirming to the TNPCB norms, and if satisfied by the Deputy Conservator the firm will be registered for empanelment for collection of waste oil from the ships as and when required by the Masters of the vessels.
- 6. The newly empanelled Recycler will be included in the list of Recyclers permitted for collection of oily wastes from the ships and the same will be published in the Port's website.
- 7. The empanelment will be valid till the period of validity of the authorization issued by the TNPCB to the Recycler.
- 8. The Recycler in the Empanelled list shall strictly comply with all the Customs Rules and Regulations, TNPCB Rules and Regulations and other statutory Regulations of the Port and other Government Departments / Organisations.
- The name of the Recycler will be removed from the list of the empanelment whenever any violations of any Rules / Regulations are noticed / brought to the knowledge of the Deputy Conservator of Chennai Port Trust.
- 10. The Deputy Conservator reserves the right to accept / reject the request of any firms for registration and empanelment for collection of oily wastes from the ships at Chennai Port and his decision will be final in this regard.

#### DEPUTY CONSERVATOR

### <u>Terms and Conditions</u> for Waste Oil Recyclers for collection of oily wastes from the <u>ships calling at Chennai Port Trust.</u>

- 1. The Recyclers authorized by the Central / state Pollution Control Board shall be empanelled in the Chennai Port for collection of oily wastes from the ships.
- 2. The Recyclers will be kept in the empanelled list as long as their Authorization issued by the Central Pollution Control Board is valid.
- 3. The Recyclers shall be required to comply with the Conditions / Regulations of Central Pollution Control Board / Tamil Nadu Pollution Control Board / Customs and Chennai Port Trust.
- 4. No Recyclers / Company will be allowed for collection of oily wastes from the ships at Chennai Port without the valid authorization from the Central / state Pollution Control Board.
- 5. Advance Notification Form is to be submitted by the vessel in the "Swaach Sagar" portal of DG(Shipping)
- 6. The Masters of the ships desirous of discharging the oily wastes at Chennai Port shall, directly or through their agents engage one of the PCB Authorized recyclers in the empanelled list of Chennai Port.
- 7. The Recyclers shall carry out the collection of oily wastes from the ship after obtaining permission from the Deputy Conservator, other Chennai Port authorities and clearance by the Customs.
- 8. The recyclers providing the service of collecting oily wastes shall be required to submit to the Marine Department the details of quantity of oily wastes collected from the ships after collection. Those recyclers who are not submitting the details will not be allowed for subsequent collection of oily wastes from the ships at Chennai Port.
- 9. The recyclers are required to fix RFID / GPS tracking system in the vehicles used by their firm for collection of the oily wastes, so as to ensure proper disposal by the firm which has collected the oily waste from the ship for disposal. Failure to adhere the above condition may result in withdrawing the registration of the firm in Chennai Port Trust.
- 10. The recyclers are required to submit copy of the Form 10 of Transport manifest of the wasteoil collected from the ship and receipt at the recyclers unit.
- 11. The decision of the Deputy Conservator is final and binding in this regard.

## **CIRCULAR**

#### **Guidelines for registration of the Private Firms for collection of Garbage**

### from the ships calling at Chennai Port Trust

- 1 The private firms authorized by the Greater Chennai Municipal Corporation or having consent of private firms engaged by Greater Chennai Corporation for solid waste management shall be empanelled in the Chennai Port for collection of garbage from the ships.
- 2 The Private Firms will be kept in the empanelled list as long as their Authorization issued by the Greater Chennai Municipal Corporation or having consent of private firms engaged by Greater Chennai Corporation is valid.
- 3 The Private Firms shall be required to comply with the Conditions / Regulations of Chennai Municipal Corporation, Customs and Chennai Port Trust.
- 4 No Private Firms will be allowed for collection of garbage from the ships at Chennai Port with out the valid authorization from the Chennai Municipal Corporation.
- 5 The Masters of the ships desirous of discharging the garbage at Chennai Port shall, directly or through their agents engage one of the Private Firms in the empanelled list of Chennai Port.
- 6 The Private Firms shall carry out the collection of garbage from the ship after obtaining permission from the Deputy Conservator, other Chennai Port authorities and clearance by the Customs and PHO.
- 7 The Private Firms providing the service of collecting garbage shall be required to submit to the Marine Department the details of quantity of garbage collected from the ships. Those Private Firms who are not submitting the details may not be allowed for subsequent collection of garbage from the ships at Chennai Port.
- 8. The Private Firms are required to fix RFID / GPS tracking system in the vehicles used by their firm for collection of the garbage, so as to ensure proper disposal by the firm which has collected the garbage from the ship for disposal. Failure to adhere the above condition may result in withdrawing the registration of the firm in Chennai Port Trust.
- 9. ANF is to be submitted by the vessel in the "Swaach Sagar" portal of DG(Shipping)
- 10. The decision of the Deputy Conservator is final and binding in this regard.
